To adopt Section 21 of Article I of the Constitution of the State of Ohio. A majority yes vote is necessary for the amendment to pass. The proposed amendment would provide that: 1. In Ohio, no law or rule shall compel, directly or indirectly, any person, employer, or health care provider to participate in a health care system. 2. In Ohio, no law or rule shall prohibit the purchase or sale of health care or health insurance. 3. In Ohio, no law or rule shall impose a penalty or fine for the sale or purchase of health care or health insurance. Shall the amendment be approved?**
